Waiver / Release of Liability

Each participant **MUST** register, read and sign this release in order to participate in this event.

In consideration of my participation in the 2018 Ride the Rogue, I hereby waive, release, and discharge any and all claims for damages, death, personal injury, or property damage which I may have, or which hereafter accrue to me, as a result of my participation in this event. This release is intended to discharge in advance, the Ride the Rogue Committee, the Rogue River Greenway Foundation, and any involved municipalities or other public agencies, from and against any and all liabilities arising out of or connected in any way with my participation in the 2018 Ride the Rogue bicycle/hike event. I further understand that serious accidents occasionally occur during bicycle riding and hikes, and that participants occasionally sustain mortal or serious personal injuries and/or property damage as a consequence thereof. Knowing the risks of bicycle riding and hiking, nevertheless, I hereby assume those risks and do hold harmless all persons or entities related to the Rogue River Greenway Foundation, involved municipalities and public agencies and all persons involved in producing this event, who (through negligence or carelessness) might otherwise be liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release and assumption of risk, is to be binding on my heirs and assigns. I acknowledge that an ANSI or SNELL certified helmet is required to be worn by me at all times while riding a bicycle in the Ride the Rogue event. By signing this release, I hereby agree to the terms of this release.

All participants under 18 must have this release signed by a parent or guardian to participate in this event – no exceptions.

All bicycle riders, walkers and hikers under 18 must be accompanied by an adult and each child/participant is required to have a completed form signed by their parent/guardian submitted.

Parents/guardians are solely responsible to meet and or pick up their children immediately after the ride/hike at the location where it started and agree that the Rogue River Greenway Foundation and Ride the Rogue event are not responsible or liable in any way for any children left unattended.

The foregoing waiver applies regarding claims in favor of my minor child/children participating in this event.
